General Information about the new yearly winter exhibition of miniature art in Copenhagen.

WHAT ?

CMA - Copenhagen Miniature Art - is a yearly open call exhibition of miniature art in Central Copenhagen. It is organized by and presented in Gallery Nybro in January every year. Jury members will be a selection of artists connected with the Gallery.

WHERE ?

Galleri Nybro is a 100% artist run exhibition space in Central Copenhagen, founded in 1989. One of the oldest still active galleries in Copenhagen.

RULES ?

Any artist, working in any style or media that fulfills the size qualifications below can participate in this open call. Works submitted may not have been shown before, not physically in exhibitions, nor online on webpages, social media, etc. or have participated in other open call exhibitions.

The maximum outer dimensions for the works submitted, including any kind of frame or mount, are:

Rectangles and ovals - 11.5 cm x 15.0 cm

Squares - 11.5 cm x 11.5 cm

Rounds - 11.5 cm in diameter.

For 3-dimensional objects:

These cannot be larger than 20 cm on the longest side - including the mount.

WHAT IS MINIATURE ART?

Miniature art is known for their impressive amount of detail, often painted in oil with very small brushes. Portraits are the main form, as are landscapes. Most art museums / Royal castles have a small collection of such miniature art on display. However, we accept all kinds of art, as long as the outer dimensions are kept. For instance you can send us video art - if the screen to view it on ("the mount") are within the size limits stated. Your works **MUST** be ready for hanging/presentation. 2-dimensional art are hanged on the walls and must have strings/etc on the back. 3-dimensional art are placed on shelves/tables/columns/etc and must be able to stand on their own.

DEADLINES

Electronic submission deadline is October 1st 2019.

1st evaluation results will be sent out on November 1st 2019.
Delivery of physical works for 2nd evaluation can take place from December 6th to December 19th. Results of 2nd evaluation will be sent out on January 1st 2020.

Vernissage weekend

Friday January 10th to Sunday January 12th 2020.

Exhibition January 7th to January 31st 2020.

Unsold works can be collected Saturday February 1st

SIGNING UP / 1st EVALUATION

1st evaluation is electronic, based upon the submission of photos of the works (photo files or pdf only, please). Maximum 5 works per participation fee. Photos must show the complete work including mount/frame/etc. The photos must be sent before October 1st 2019. Please email cphminiart@outlook.dk
Remember to include in your mail the filled out application form, and a receipt of the payment of the fee (150 DKK).
Results of the 1st evaluation on November 1st 2019 by email.

DELIVERY 2nd EVALUATION

Works that passed the 1st evaluation can be delivered physically to Gallery Nybro during our Christmas Exhibition 2019. Not accepted works can be collected during the CMA 2020 exhibition, or at the end of the exhibition, on Saturday February 1st 2020.

PLEASE NOTE!

If you mail in your work (use this address: Gallery Nybro, Nybrogade 30, 1203 København K, Denmark), we will charge you an extra fee to return your rejected/unsold works: Actual cost of the insured return shipment with PostNord + 100 DKK packaging fee. Once you've paid, we will return your works. If your work is sold during the exhibition, we'll send the amount to your bank account. You'll pay any fees for this transaction.

IMPORTANT INFORMATION

DATA PROTECTION (GDPR)

We will not share your personal info with third parts, but only in use for the process surrounding the exhibition for which you have applied. Only the appointed jury members have access to your full information on the application form. By participating in CMA, you give Gallery Nybro your permission to permanently share certain personal identifying information online (in the catalog next to your works - marked by yellow fields in the application form). Only your email will be stored, with the purpose of inviting you to later CMAs. All other information will be deleted afterwards.

INSURANCE

The art works are not insured by Gallery NYBRO at all. If you wish to insure your works for transport, storage, or exhibition (before, during, and after the exhibition / against damage, fire, theft, loss, etc) – you must arrange and pay for this yourself.

FEES

Galleri Nybro does not take any extra fees for exhibited artworks or fees in connection with sales from the exhibition. You only pay the participation fee and – if applicable – for the packing and return shipment of your works by post.
